Severe Movement Securities (严重异常波动证券) – Securities that have met specific exchange defined criteria with respect to severe securities price movement. Securities list available on SSE / SZSE websites and from data vendor.

- Trading subject to abnormal trading surveillance with thresholds tightened by up to 50%
- Trading pace monitoring [RMB 10m per minute / reduced to RMB 2m per minute for severe movement stocks that are ST at the same time]

Risk Reminder Securities (风险提示函证券) – Securities that exchange deems necessary to remind investors about risk of trading e.g. sharp moves in securities price that exchange considers deviated from company fundamentals. Securities list compiled based on ad-hoc, non-public exchange communication.

- Trading subject to abnormal trading surveillance with thresholds tightened by up to 50% on side of reminder [buy or sell]
